Set up your Amazon Global Logistics account

You can start using Amazon Global Logistics in Seller Central by creating an account or linking your existing Amazon Global Logistics account (step 1.3 below).

STEP 1.0

In Seller Central, select **Inventory**, then **Manage FBA Inventory**. Select your ASIN and then **Send/replenish inventory** in the drop-down menu to the right.







Set up importer of record (IOR) and customs bond

To submit shipments, you must have an IOR and continuous bond for cross-border customs clearance.

STEP 3.0


Whether your invoice is issued in CNY or you've set up a payment method, an IOR is required for submitting a shipment.



Start by clicking **Importer of record (IOR)**. If desired, you can also link your existing Amazon Global Logistics account. **Note:** If you link your Amazon Global Logistics account, it will overwrite the information in Seller Central.

STEP 3.1

Click **Add new importer of record (IOR)**.



STEP 3.2

If you don't have an importer number (either an Employer Identification Number or a Customs Assigned Importer Number), select **No, the importer does not have a CAIN. Request one for me.** If you do have one of these numbers, select **Yes, the importer has an EIN or CAIN.**

**In the example below, the applicant is a company in mainland China with no Customs Assigned Importer Number (or CAIN, sometimes called an importer number) and has never imported goods into the US under the name of the IOR.*

STEP 3.3

After you select **No, the importer does not have a CAIN. Request one for me,** make sure to check the box next to **I'm sure I want Amazon to request a CAIN for me** to proceed. These steps will allow Amazon to request a CAIN for the importer. When you're finished, click **Next.**

STEP 3.6

Select the title of the person who will sign the power of attorney (POA) from the **POA Signer role** drop-down menu. Enter the person's name in the **POA signer's name** field, and enter the email address of the signer in the **POA signatory email address** field. The email address will be used to send the POA to the signer for their e-signature.

For non-US resident companies, enter **Importer Non-resident Corporate Certification Details** for a second officer. This is required for the completion of an NRCC.

Note: The second officer must be a different person than the POA signer. If you have only one officer in your company as a non-US resident business, check the box next to **I only have one officer**. This step will allow you to enter another employee for the completion of the NRCC. When you're finished, click **Next**.

STEP 3.7

Select the number of times per year that the IOR entity will be importing into the US. This information involves not only Amazon-related imports for the company, but all imports throughout the year. Answer whether there is an existing bond for the IOR.

In the example above, the importer does not have a bond and asks Amazon to buy one. If you already have a bond, select **Yes.*

STEP 3.8

If the IOR does not have a bond, select **No** to request a bond purchase. Then click **Buy bond**.

STEP 3.12

If you select **Yes** to the question **Has the IOR imported before?**, there will be an option to have duties, taxes, and fees for shipments charged against an **automated clearing house (ACH) account**. This account will have been previously set up with US Customs and Border Protection, which would have provided a Payer Unit Number (PUN) for the account. If you want to use this account, select **Yes** and then enter your PUN in the **Duty and tax account number** field. Finally, enter an email address for the IOR where final entry summaries for the shipment should be sent. Then click **Next**.
